**Rules of the Parade**

- All riders must follow rules and instruction (given at \*riders meeting) or be subject to non participation.
- Registration form is to be complete and signed by parent/guardian prior to event.

- All "Riders" will attend \*riders meeting at 9:00 a.m. at Garrett Park by the information booth.
- Riders 12 & under must wear bicycle helmet & shoes. Dress comfortable it will be hot!
- Bicycle must be **decorated**, (helmet & rider optional). Make it Fun "Go~Green"!
- Rider's must be courteous to fellow riders and practice safety at all times.
- Participants receive: prize & recognition for participation.

**Hold Harmless Agreement**

**Release:** By the signature appearing above, and in consideration of the acceptance of my child's application for entry in the Pioneer Days Decorated Bicycle Parade, I hereby waive, release, and discharge any and all claims for injury or damage, whether personal or to property, which I may have or which may hereafter occur to me against the Lemon Bay Historical Society, The Coastal Cruisers, the parade marshal and the persons or entities organizing and acting in concert with them in connection with the Pioneer Days Parade ("Parade Sponsors") as a result of my/my child(ren) participation in said event.

**Assumption of Risk:** I understand that accidents occasionally occur during parades and that participants and spectators in parades occasionally sustain personal injuries or property damage as a consequence thereof. Knowing the risks, nevertheless, I hereby agree to assume those risks and to release and hold harmless all of the Parade Sponsors who, through negligence or carelessness, might otherwise be liable to me/us. *Indemnification:* I further agree to indemnify, defend, and hold the Parade Sponsors, their directors, officers, employees and agents, harmless from and defend any action brought against them with respect to any claim, demand, cause of action, debt or liability, to the extent that the same, if meritorious, arises out of the negligence or willful misconduct on my/our part.

**Furthermore:** I give my permission for my child to participate in the Pioneer Days – Decorated Bicycle Parade. I also grant permission to event personnel and event organizers to authorize and obtain medical care or treatment from any licensed medical support associated with the parade rules and regulations should the child become ill or injured while participating in the Pioneer Days Decorated Bicycle Parade when neither parent/guardian is available to grant authorization for emergency treatment. *By the signature appearing above, the named entrant agrees to abide by the rules and regulations, hold harmless agreement and release. I grant permission to use my child's photo and name in any publication that promotes the parade in positive manner.*
